Parking Restrictions at Mt Seymour and Cypress Alex Wallace for the FMCBC SW BC Trails Committee

The FMCBC has had several meetings in the last year to try and resolve the issue of parking restrictions at Mt Seymour and although these have been informative, no resolution has been reached. BC Parks is monitoring the situation and gathering data by several means on numbers of backcountry users at both Cypress and Mount Seymour parks (where the backcountry parking restrictions are now in place) and a Mount Seymour Park planning process is expected to roll out in the next few months. BC Parks has asked for feedback, and the FMCBC is encouraging this. [Read More.](#)

Coquihalla Summit Recreation Area Parking Scott Webster for the SW BC Recreation & Conservation Committee

Some of our members have noticed new signs at the Zopkios Rest Area on the Coquihalla Highway. These signs suggest that users should limit their stay to one hour. The FMCBC has been in contact with BC Parks and the Ministry of Transportation and has confirmed that these signs are not targeted at backcountry users. There is an ongoing problem, mostly during the winter, with the rest area filling with trucks, causing delays on the highway. Backcountry users should try to park in "the usual place" near the washrooms and feel free to stay longer than one hour. Please always be careful to park in a way that does not impede traffic. The FMCBC is working with the relevant parties to find a long term solution with more appropriate signage.

Backcountry Access for the Callaghan Valley Scott Webster for the SW BC Recreation & Conservation Committee

The designated overnight and after-hours parking area for the Callaghan Valley is at the Alexander Falls Recreation Site this year. Some backcountry users have experienced conflict with Callaghan Country when parking here and then passing by the Callaghan Country base area on their way to their destination. An alternate route is via the water treatment facility. Immediately after turning left onto the turnoff for Callaghan Country, instead of taking the bridge over the creek, turn right onto the gated road. We believe that signs on the gate are not intended for skiers. This road then links up with the WOP trail network. Continue on the trails if you have paid the WOP fee or head into the backcountry from this point. We are working on a longer term solution that makes the access point from Alexander Falls more clear.
